Applicant must submit a physical sample, sales and technical literature for all products.

Independent Testing is required for Hinges and Drawer Slides and **MUST BE INCLUDED** with this application. As per NAAWS Section 10, Casework, Subsections 10.5.1 through 10.5.1.2, 10.5.1.5 and 10.5.1.8 testing requires that:

- Hardware will conform to ANSI/BHMA Standards, minimum grade 2 requirements except for requiring “dynamic” load testing for a minimum of 50,000 cycles
- Hinges will be a minimum of 110 degrees opening capacity meeting ANSI/BHMA 156.9 and if being used in schools, hospitals or laboratories shall be tested to Grade 1 requirements.
- Drawer Slide Testing will be based on a drawer slide nominal length of 22” (559mm) mounted on drawer box:
 - 22” (559mm) in depth with a minimum width of 18” (457mm) for load ratings up to 125 lbs. (56.7kg)
 - 24” (610mm) in width for load ratings of 125 lbs. (56.7kg) and above
- Slides not manufactured in lengths up to 22” (559mm) will be tested in their longest production length
- Have the material suppliers name or unique brand marking stamped on hinges, slides, and locks for identification purposes
